NOTICE OF BID

The Hayden Lake Irrigation District is accepting sealed bids for the purchase of a surplus 2013 F-150 XL 4x4 vehicle, as described below. Bids must be received at the District's office located at 2160 W Dakota Avenue, Hayden, Idaho.

Bidders may submit only one (1) signed original BID Form, which must be complete and free from ambiguity. Bids will be accepted by the District until May 6th, 2025, at noon. They will be opened and awarded during the regular Board meeting on the same day, May 6th, 2025, at 5 p.m.

****Description:** 2013 Ford F-150 XL 4x4 Extended Cab with a service locking canopy. Mileage: 60,991.3 miles.**

Conditions:

This is a work truck that has dings and scratches. It features vinyl seats, an AM/FM radio, a bed slide, a power inverter, a ladder rack, exterior lighting, power windows, power locks, a tow package, running boards, and a remote key fob. The original tailgate and mirrors are included with the purchase of the truck.

The vehicle has had all the routine maintenance and inspections performed annually. **This is being sold as-is, without any guarantees or warranties.**

Minimum Bid Requirement: \$8,000.00

Each bidder must complete and sign the attached Bid Form. The form must be signed by a person authorized to bind the bidder to a legal agreement. Please note that all bid submissions will become the property of the District and are non-returnable. Bids must be complete and free from ambiguity. All submitted bids shall remain valid for a minimum of ninety (90) days.

Bids must be submitted in a sealed envelope, clearly labeled on the outside with the following information: "Invitation for Bid: Sale of Surplus 2013 Ford F-150 XL."

Bids may be mailed or hand-delivered to the District's Office at 2160 West Dakota Avenue Hayden, ID 83835

If hand-delivered

The District reserves the right to select a bid that it believes is in its best interest. This includes considering factors such as the highest and best use of the property, a favorable exchange of property, or the highest bid amount. Once notified of their selection, the bidder has ten (10) business days—unless an extension is granted at the sole discretion of the District—to submit a cashier's check for the total bid amount for the subject property. If the bidder fails to submit the cashier's check and/or an executed letter of agreement agreeing to all conditions, the bid may be rejected. In such a case, the District may choose the next bid that it feels is in its best interest or may reject all bids.

Additionally, the District maintains the right to reject any or all bids and to waive any minor irregularities or technicalities. The District may also reject a bid if it receives more than one bid from the same individual/entity or if collusion among bidders is suspected. Incomplete bid submissions may not be considered.
