ANNUAL IRRIGATION ASSESSMENT

Tract Fee	\$41.00
Maintenance	\$70.70 Per Acre or Less
EPA/DEQ	\$10.00

Total \$121.70 for 1-acre lots.

Lots greater than 1 acre, multiply additional acreage by \$70.70, and add to \$121.70 for the total.

Irrigation Allotment:	326,000 Gallons Per Acre or Fraction Thereof
Irrigation Overage	\$2.00 Per 1,000 Gallons Over Allotment

Irrigation Assessments are billed in the fall and are due by December 20th of that year. If the first half is paid by December 20th, then the second half is due by June 20th of the following year. No statement is sent for the second half. Failure to pay the irrigation assessment will result in a penalty and interest at the stated rates below under Terms of Payment.

TERMS OF PAYMENT 2026

All charges are to be paid by the due date listed on the invoice, or late fees will be applied. Payment methods include cash, check, and credit/debit cards. We accept cash and checks in the office or via mail. We also accept credit/debit or check/savings payments on our website or by calling the phone number listed below; there is a flat rate charged by the payment provider. There is a drop box available at the District office available 24/7.

If you elect to pay through your bank, please keep in mind that some banks issue checks, and it can take up to 10 days for us to receive your payment. If you receive a late notice and your payment is not received by the District office by the date specified, a door tag will be hung for service disconnection, and you will be charged the appropriate fees.

Late Fees are applied to accounts on the fourth (4th) business day after the due date.

Delinquent Accounts will be charged the following:

Late Fee: \$15.00
Penalty: 2% of past due balance
Interest: 1% per month on past due balance
Door Tag Fee: \$20.00
Services disconnected for non-payment: \$50.00

The District will post a door tag on the door providing the date and time of the disconnection before the service is disconnected. If a door tag is received, the account will receive a door tag fee. If the service is disconnected, the account will be charged a \$25.00 lock-off fee and a \$25.00 fee to turn the water back on. Accounts must be paid in full before service can be restored.

Domestic bills are sent at the beginning of the following months and are due by the end of that month:
